



The relative strengths and weaknesses of Wohnungsbaugesellschaft Bergstadt Schneeberg mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft Bergstadt Schneeberg mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 45% points. The greatest weakness of Wohnungsbaugesellschaft Bergstadt Schneeberg mit Beschränkter Haftung is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 257% points.

The company's Economic Capital Ratio, given in the ranking table, is 45%, being 57% points below the market average of 102%.
