



The relative strengths and weaknesses of Wohnungsbaugesellschaft Plauen mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft Plauen mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 98% points. The greatest weakness of Wohnungsbaugesellschaft Plauen mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 262% points.

The company's Economic Capital Ratio, given in the ranking table, is 98%, being 3,4% points below the market average of 102%.
