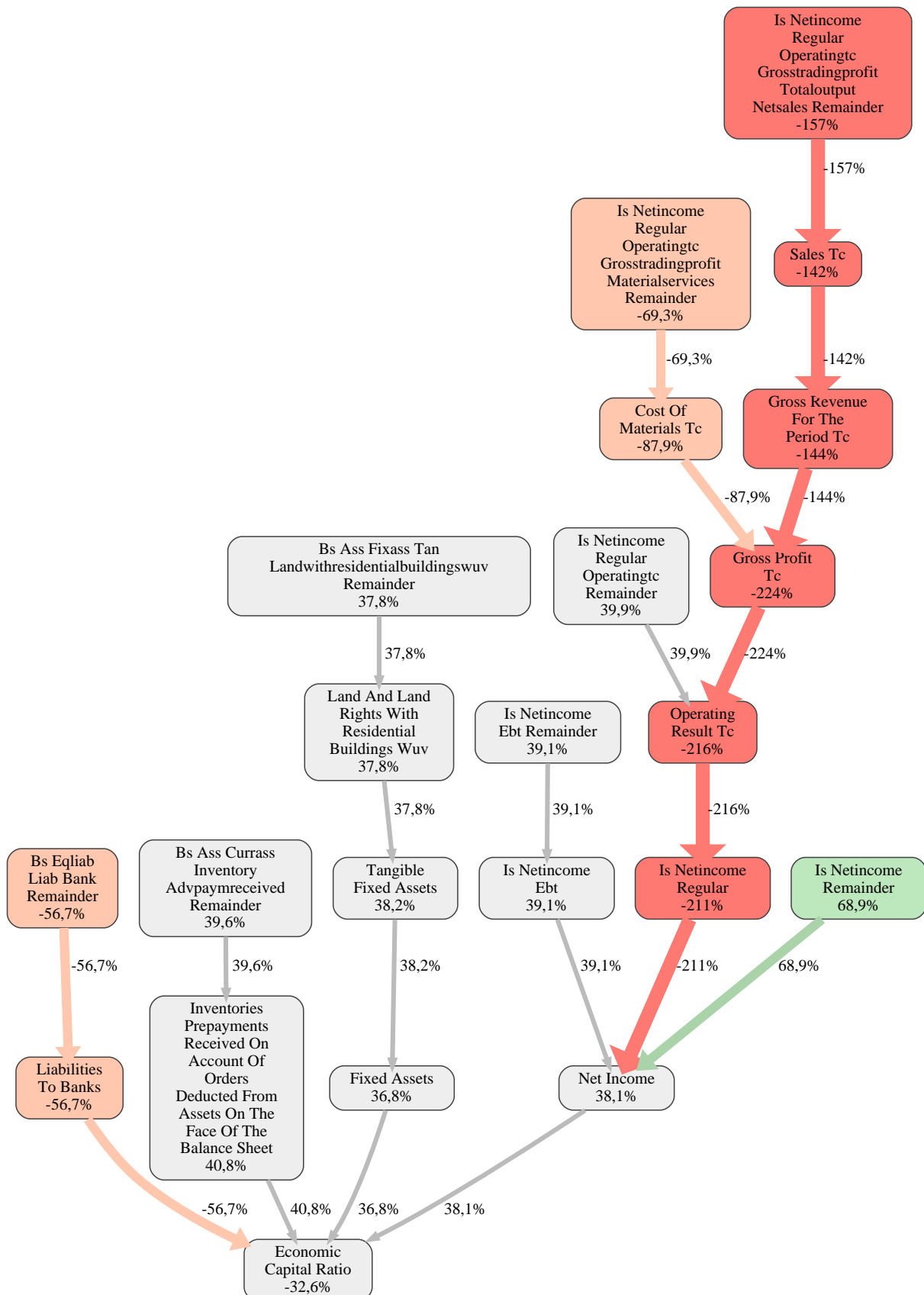

The relative strengths and weaknesses of Wildauer Wohnungsbaugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wildauer Wohnungsbaugesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 69% points. The greatest weakness of Wildauer Wohnungsbaugesellschaft mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 224% points.

The company's Economic Capital Ratio, given in the ranking table, is 69%, being 33% points below the market average of 102%.
