



The relative strengths and weaknesses of Kommunale Immobilien Dresden GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kommunale Immobilien Dresden GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 94% points. The greatest weakness of Kommunale Immobilien Dresden GmbH Co KG is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 272% points.

The company's Economic Capital Ratio, given in the ranking table, is 94%, being 7,8% points below the market average of 102%.
