



The relative strengths and weaknesses of Wohnungsbaugesellschaft Rüdersdorf mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft Rüdersdorf mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 109% points. The greatest weakness of Wohnungsbaugesellschaft Rüdersdorf mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 263% points.

The company's Economic Capital Ratio, given in the ranking table, is 109%, being 7,9% points above the market average of 102%.
