

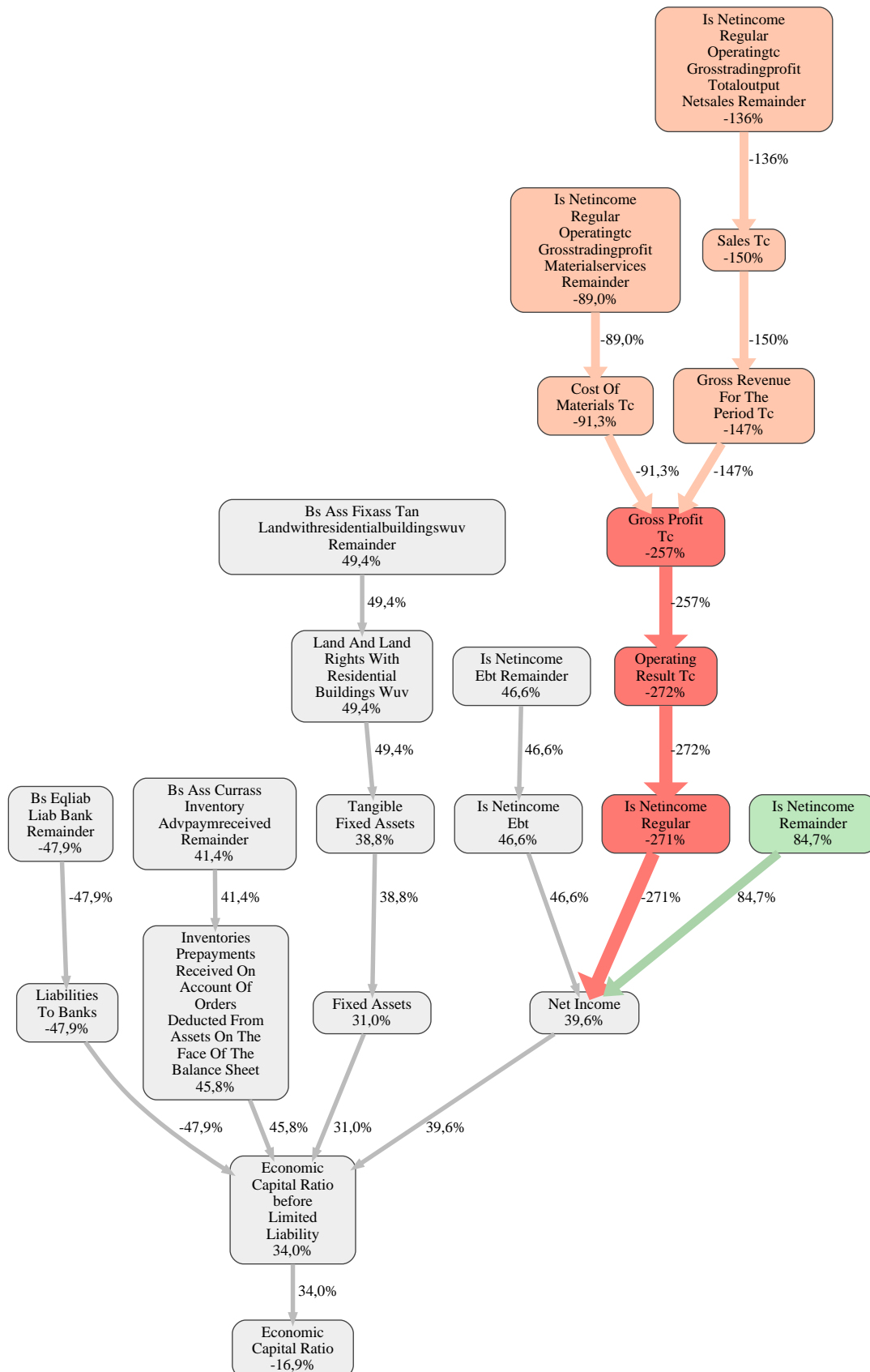

The relative strengths and weaknesses of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Freiburger Stadtbau Gesellschaft mit Beschränkter Haftung FSB is the variable Operating Result Tc, reducing the Economic Capital Ratio by 272% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 17% points below the market average of 102%.
