The greatest strength of GVV Städtische Wohnbaugesellschaft Singen mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 41% points. The greatest weakness of GVV Städtische Wohnbaugesellschaft Singen mbH is the variable Operating Result Tc, reducing the Economic Capital Ratio by 258% points.

The company's Economic Capital Ratio, given in the ranking table, is 41%, being 60% points below the market average of 102%.
