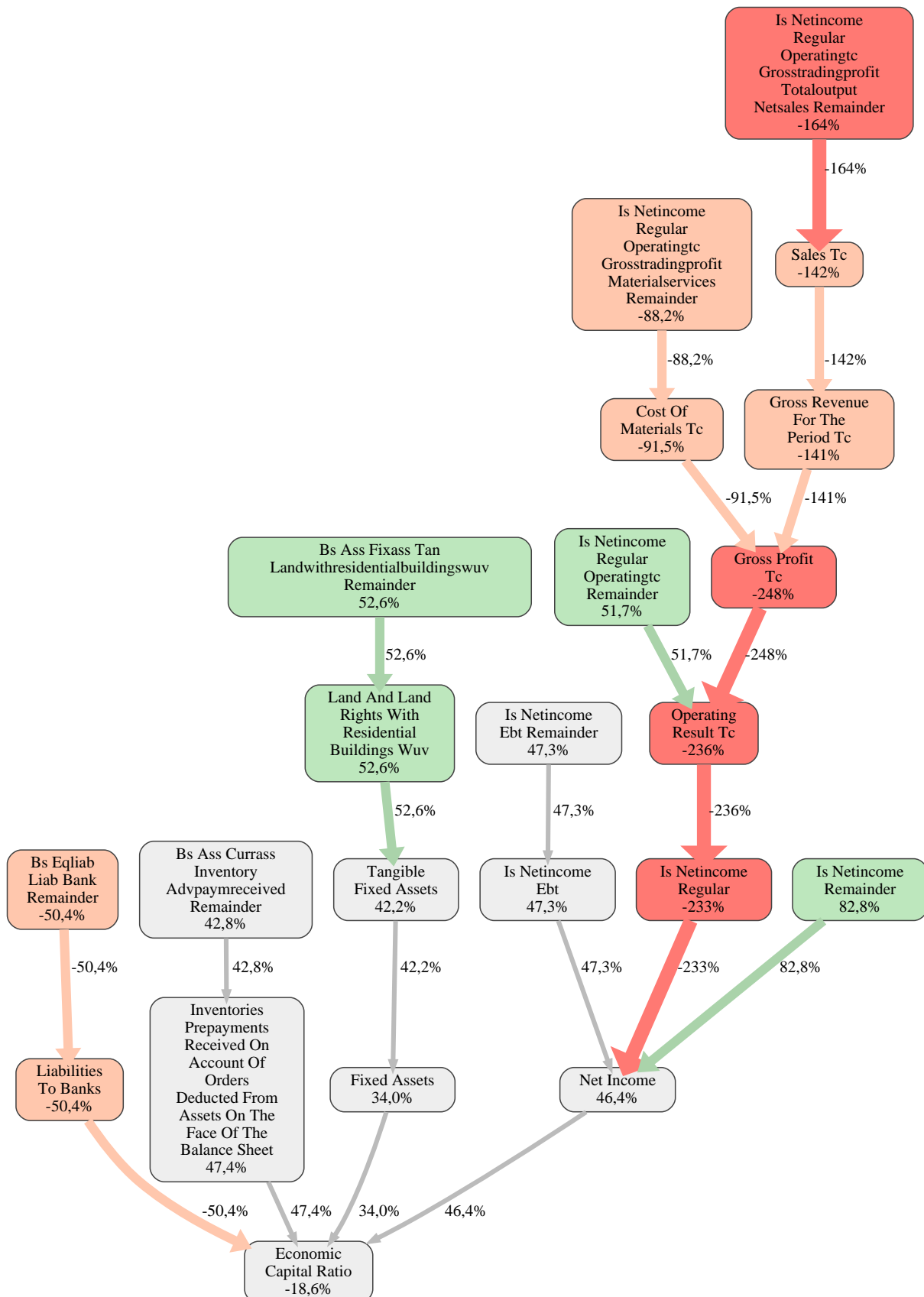

The relative strengths and weaknesses of Städtische Wohnungsbaugesellschaft mbH Rheinfelden are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Städtische Wohnungsbaugesellschaft mbH Rheinfelden compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 83% points. The greatest weakness of Städtische Wohnungsbaugesellschaft mbH Rheinfelden is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 248% points.

The company's Economic Capital Ratio, given in the ranking table, is 83%, being 19% points below the market average of 102%.
