



Kommunales Wohnungsunternehmen Prenzlau Land Gesellschaft mit Beschränkter Haftung Rank 143 of 325

The relative strengths and weaknesses of Kommunales Wohnungsunternehmen Prenzlau Land Gesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Kommunales Wohnungsunternehmen Prenzlau Land Gesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 91% points. The greatest weakness of Kommunales Wohnungsunternehmen Prenzlau Land Gesellschaft mit Beschränkter Haftung is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 250% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 9,8% points below the market average of 102%.
