



The relative strengths and weaknesses of Wohnungsbaugesellschaft mbH Oranienburg WOBA are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbaugesellschaft mbH Oranienburg WOBA compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 92% points. The greatest weakness of Wohnungsbaugesellschaft mbH Oranienburg WOBA is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 259% points.

The company's Economic Capital Ratio, given in the ranking table, is 92%, being 9,1% points below the market average of 102%.
