



The relative strengths and weaknesses of Wohnungsbau und Verwaltungsgesellschaft mbH Greifswald are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau und Verwaltungsgesellschaft mbH Greifswald compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Wohnungsbau und Verwaltungsgesellschaft mbH Greifswald is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 252% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 16% points below the market average of 102%.
