



The relative strengths and weaknesses of KSG Kreissiedlungsgesellschaft mbH des Landkreises Hameln Pyrmont are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of KSG Kreissiedlungsgesellschaft mbH des Landkreises Hameln Pyrmont compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 77% points. The greatest weakness of KSG Kreissiedlungsgesellschaft mbH des Landkreises Hameln Pyrmont is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 248% points.

The company's Economic Capital Ratio, given in the ranking table, is 77%, being 25% points below the market average of 102%.
