



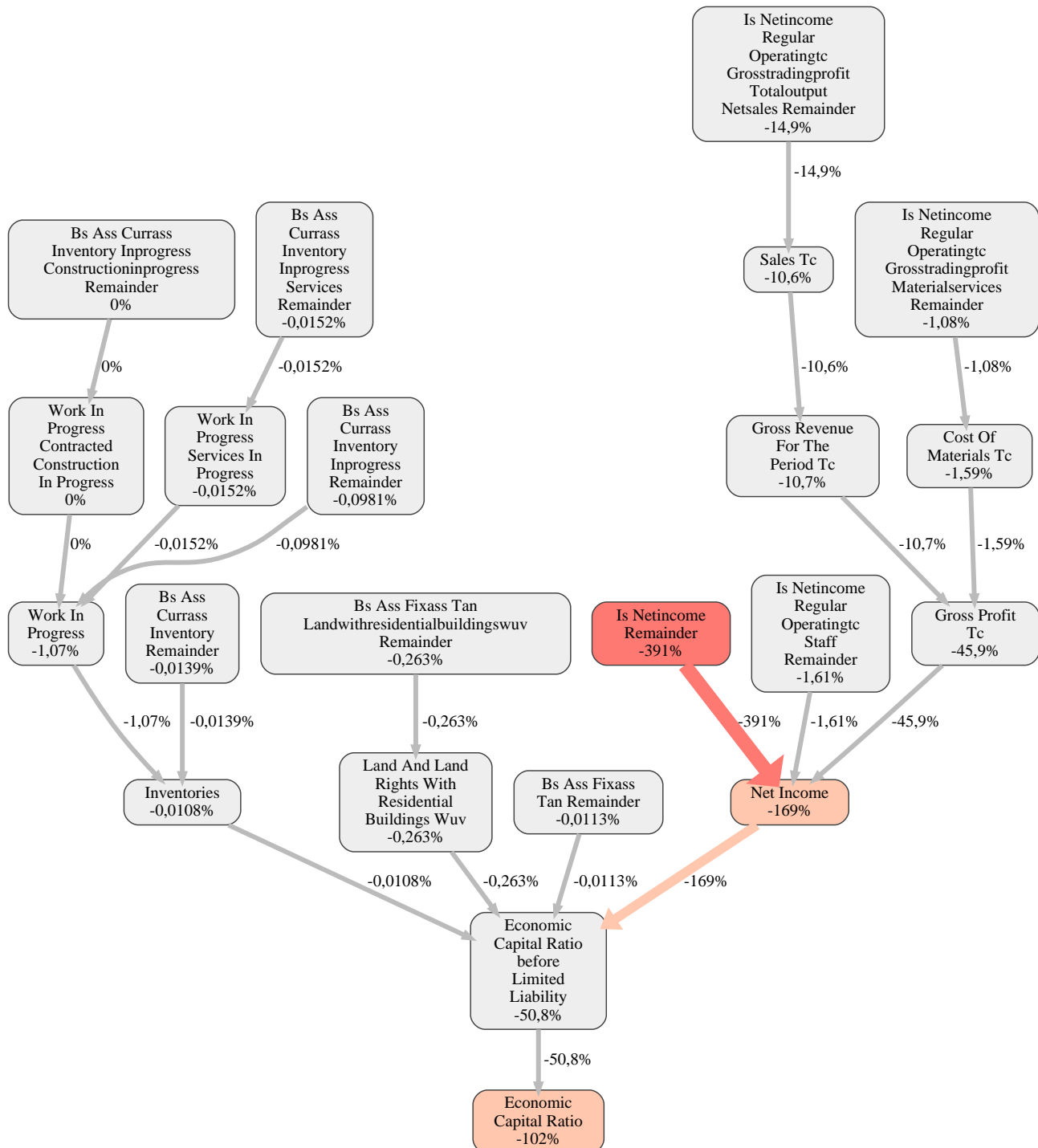

The greatest strength of wb Service GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Staff Salaries Remainder, increasing the Economic Capital Ratio by 0,0016% points. The greatest weakness of wb Service GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 391% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,0016%, being 102% points below the market average of 102%.
