The greatest strength of Takenaka Europe GmbH compared to the market average is the variable Is Netincome Regular Operatingcogs Grossoprofit Remainder, increasing the Economic Capital Ratio by 61% points. The greatest weakness of Takenaka Europe GmbH is the variable Is Netincome Regular Operatingcogs Grossoprofit Cogs Remainder, reducing the Economic Capital Ratio by 139% points.

The company's Economic Capital Ratio, given in the ranking table, is 62%, being 40% points below the market average of 102%.
