



The relative strengths and weaknesses of Wassmann und Söhne GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wassmann und Söhne GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 220% points. The greatest weakness of Wassmann und Söhne GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 928% points.

The company's Economic Capital Ratio, given in the ranking table, is 220%, being 119% points above the market average of 102%.
