



The relative strengths and weaknesses of Johann Feldbauer Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Johann Feldbauer Bau GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 153% points. The greatest weakness of Johann Feldbauer Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 765% points.

The company's Economic Capital Ratio, given in the ranking table, is 153%, being 51% points above the market average of 102%.
