

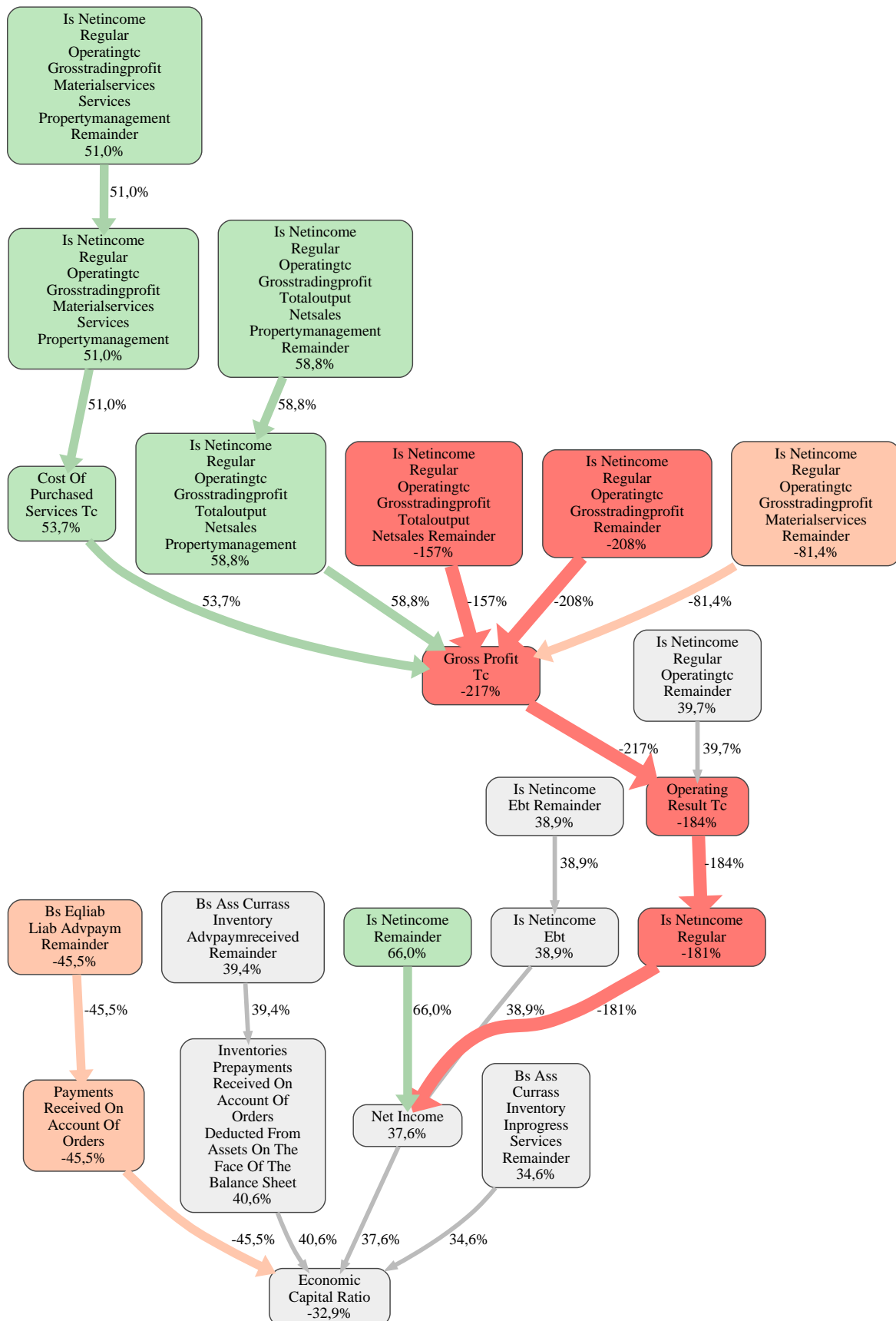

The relative strengths and weaknesses of BBS Bau und Betriebsservice GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of BBS Bau und Betriebsservice GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 66% points. The greatest weakness of BBS Bau und Betriebsservice GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 217% points.

The company's Economic Capital Ratio, given in the ranking table, is 69%, being 33% points below the market average of 102%.
