



The relative strengths and weaknesses of MBN GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of MBN GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 110% points. The greatest weakness of MBN GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 646% points.

The company's Economic Capital Ratio, given in the ranking table, is 110%, being 8,2% points above the market average of 102%.
