



The relative strengths and weaknesses of Mainka Bau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Mainka Bau GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 134% points. The greatest weakness of Mainka Bau GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.393% points.

The company's Economic Capital Ratio, given in the ranking table, is 134%, being 33% points above the market average of 102%.
