



The relative strengths and weaknesses of Schielicke BAU Hoch Tief und Ingenieurbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schielicke BAU Hoch Tief und Ingenieurbau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 139% points. The greatest weakness of Schielicke BAU Hoch Tief und Ingenieurbau GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 347% points.

The company's Economic Capital Ratio, given in the ranking table, is 141%, being 39% points above the market average of 102%.
