

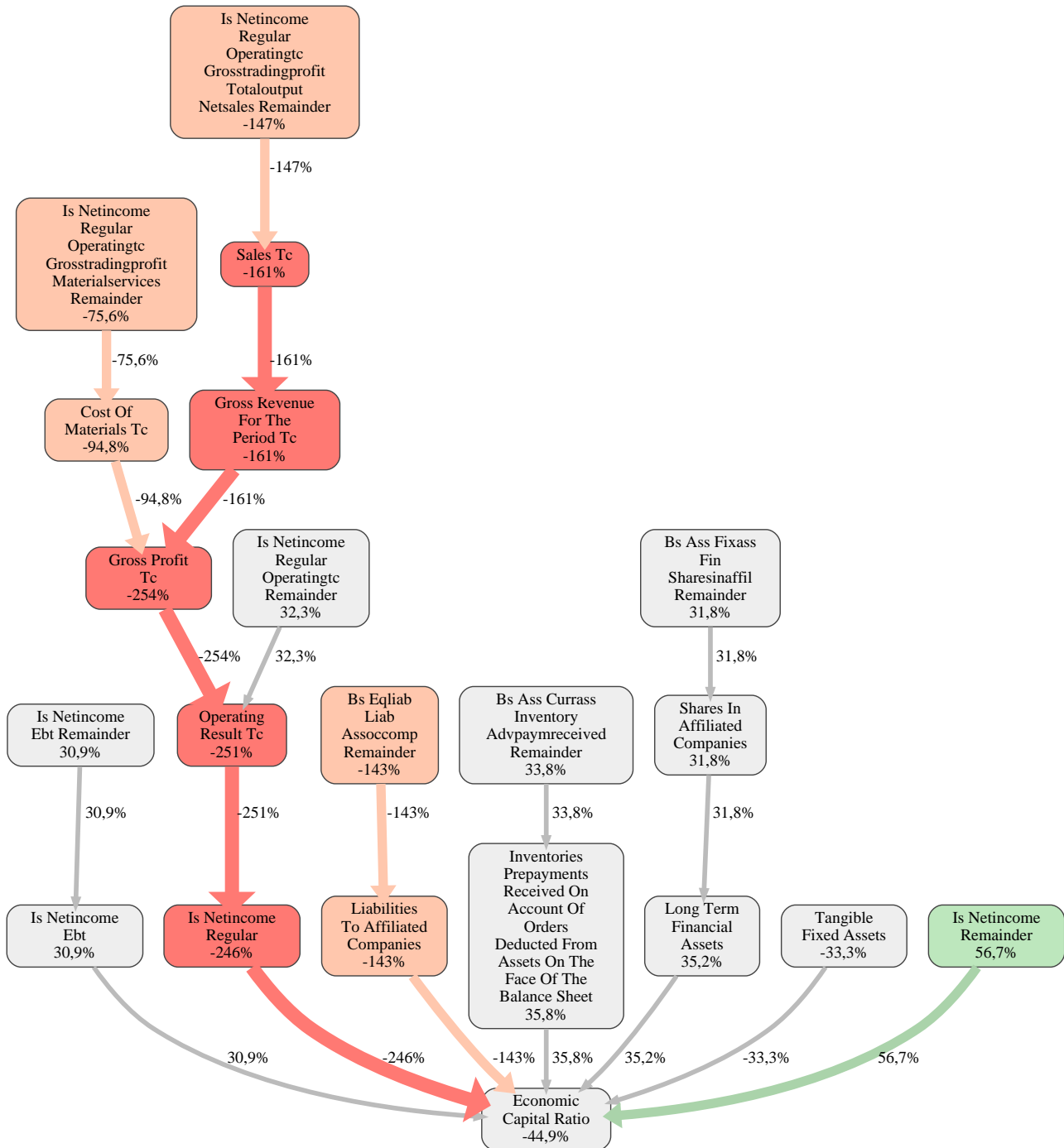

The relative strengths and weaknesses of Implenla Deutschland GmbH Vormal's Implenla Holding GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Implenla Deutschland GmbH Vormal's Implenla Holding GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 57% points. The greatest weakness of Implenla Deutschland GmbH Vormal's Implenla Holding GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 254% points.

The company's Economic Capital Ratio, given in the ranking table, is 57%, being 45% points below the market average of 102%.
