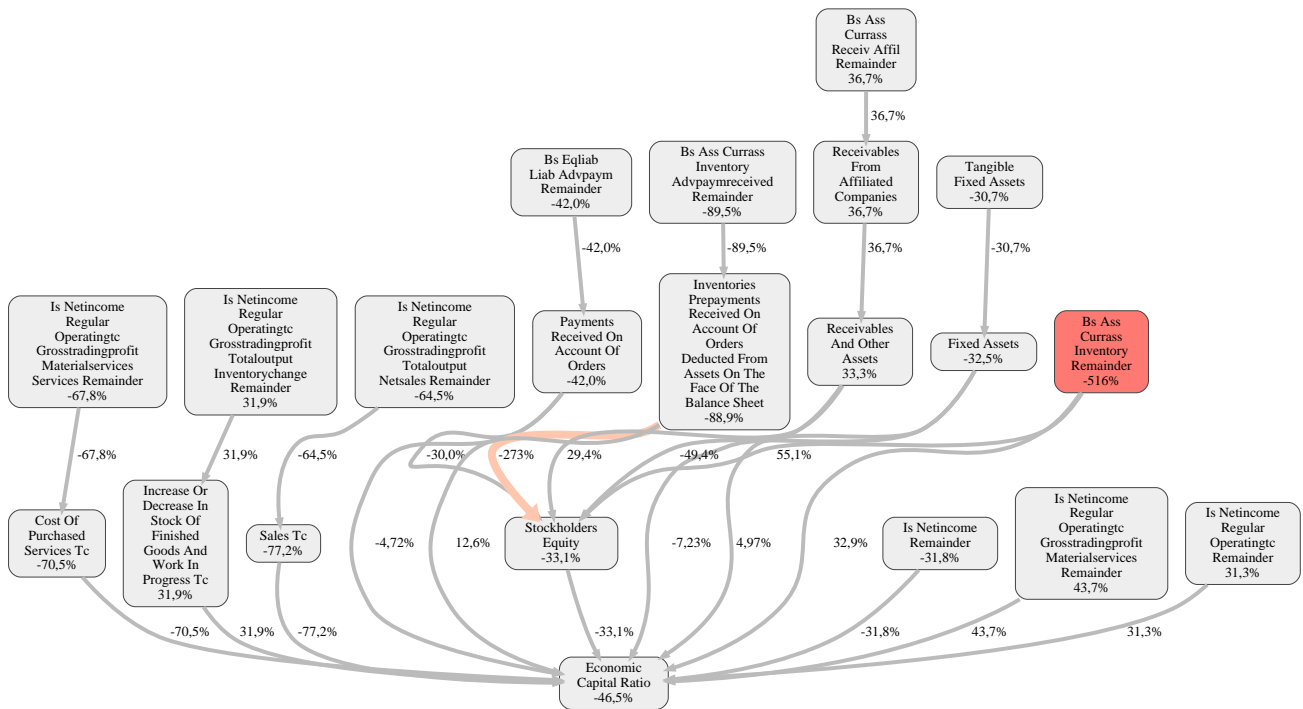

The relative strengths and weaknesses of Implenia Civil Engineering GmbH Vormals Implenia Construction GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Implenia Civil Engineering GmbH Vormals Implenia Construction GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 44% points. The greatest weakness of Implenia Civil Engineering GmbH Vormals Implenia Construction GmbH is the variable Bs Ass Currass Inventory Remainder, reducing the Economic Capital Ratio by 516% points.

The company's Economic Capital Ratio, given in the ranking table, is 55%, being 47% points below the market average of 102%.
