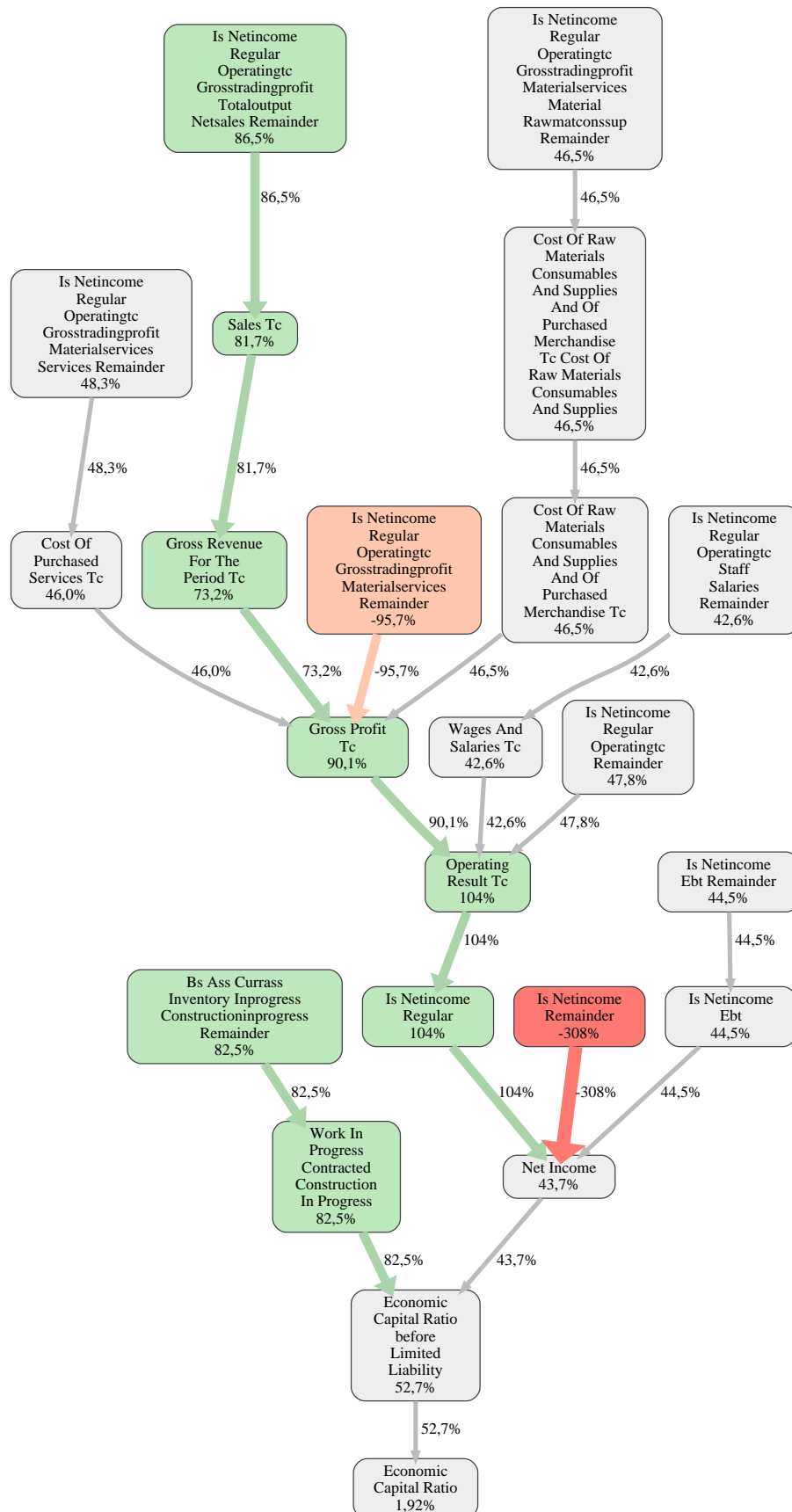

The greatest strength of Kurt Motz Holding GmbH Co KG Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 104% points. The greatest weakness of Kurt Motz Holding GmbH Co KG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 308% points.

The company's Economic Capital Ratio, given in the ranking table, is 104%, being 1,9% points above the market average of 102%.
