The greatest strength of Wohnbaugruppe Augsburg Leben GmbH Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 68% points. The greatest weakness of Wohnbaugruppe Augsburg Leben GmbH Konzern is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 249% points.

The company's Economic Capital Ratio, given in the ranking table, is 68%, being 34% points below the market average of 102%.
