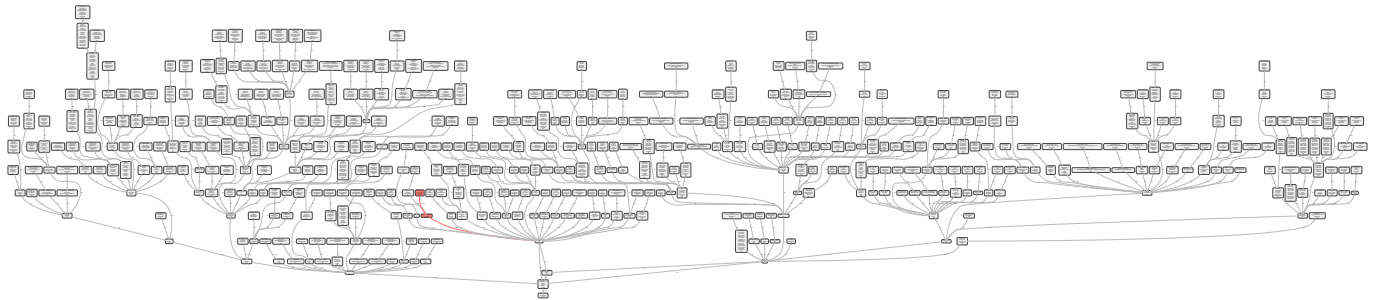

The relative strengths and weaknesses of Howoge Wohnungsbaugesellschaft mit Beschränkter Haftung Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest weakness of Howoge Wohnungsbaugesellschaft mit Beschränkter Haftung Konzern is the variable Trade Payables, reducing the Economic Capital Ratio by 2.818% points.

The company's Economic Capital Ratio, given in the ranking table, is 0%, being 102% points below the market average of 102%.
