



The relative strengths and weaknesses of W Hundhausen Bauunternehmung GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of W Hundhausen Bauunternehmung GmbH Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 158% points. The greatest weakness of W Hundhausen Bauunternehmung GmbH Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 735% points.

The company's Economic Capital Ratio, given in the ranking table, is 158%, being 56% points above the market average of 102%.
