



The relative strengths and weaknesses of J J Beteiligungen GmbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of J J Beteiligungen GmbH Co KG Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 65% points. The greatest weakness of J J Beteiligungen GmbH Co KG Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 396% points.

The company's Economic Capital Ratio, given in the ranking table, is 65%, being 37% points below the market average of 102%.
