The greatest strength of Peter Ahrens Bauunternehmen GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 71% points. The greatest weakness of Peter Ahrens Bauunternehmen GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 548% points.

The company's Economic Capital Ratio, given in the ranking table, is 71%, being 28% points below the market average of 100%.
