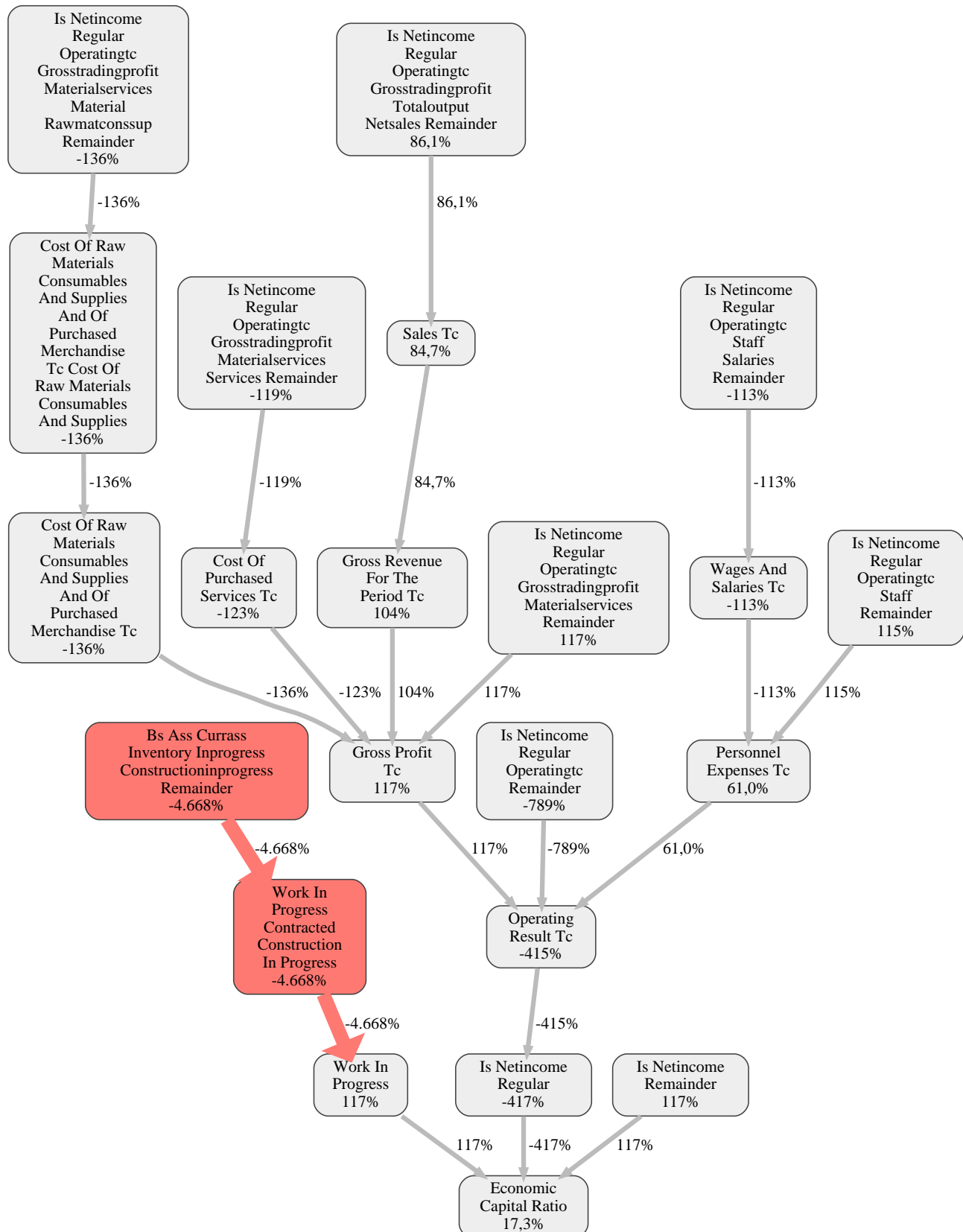

The greatest strength of Wadle Bauunternehmung GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 117% points. The greatest weakness of Wadle Bauunternehmung GmbH is the variable Bs Ass Currass Inventory Inprogress Constructioninprogress Remainder, reducing the Economic Capital Ratio by 4.668% points.

The company's Economic Capital Ratio, given in the ranking table, is 117%, being 17% points above the market average of 100%.
