The greatest strength of Hans Holzner Baugesellschaft mbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 52% points. The greatest weakness of Hans Holzner Baugesellschaft mbH is the variable Bs Ass Currass Inventory Remainder, reducing the Economic Capital Ratio by 316% points.

The company's Economic Capital Ratio, given in the ranking table, is 53%, being 47% points below the market average of 100%.
