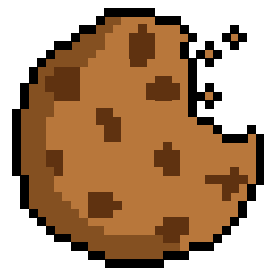

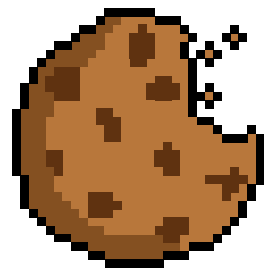
The greatest strength of Gesobau Wohnen GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 49% points. The greatest weakness of Gesobau Wohnen GmbH Co KG is the variable Operating Result Tc, reducing the Economic Capital Ratio by 380% points.

The company's Economic Capital Ratio, given in the ranking table, is 49%, being 51% points below the market average of 100%.

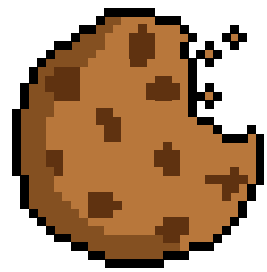
