The greatest strength of Laudemann GmbH Bauunternehmen compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 105% points. The greatest weakness of Laudemann GmbH Bauunternehmen is the variable Is Netincome Regular Operatingtc Staff Social Remainder, reducing the Economic Capital Ratio by 2.372.231% points.

The company's Economic Capital Ratio, given in the ranking table, is 105%, being 7,6% points above the market average of 98%.
