The greatest strength of Rensch Haus GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 95% points. The greatest weakness of Rensch Haus GmbH is the variable Social Security Post Employment And Other Employee Benefit Costs Tc, reducing the Economic Capital Ratio by 2.372.283% points.

The company's Economic Capital Ratio, given in the ranking table, is 95%, being 2,2% points below the market average of 98%.
