



The relative strengths and weaknesses of Stadtbau GmbH Deggendorf are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stadtbau GmbH Deggendorf compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Stadtbau GmbH Deggendorf is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.465% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 13% points below the market average of 98%.
