The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 116% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Social Security Post Employment And Other Employee Benefit Costs Tc, reducing the Economic Capital Ratio by 2.372.245% points.

The company's Economic Capital Ratio, given in the ranking table, is 116%, being 18% points above the market average of 98%.
