



The relative strengths and weaknesses of Glass GmbH Bauunternehmung Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Glass GmbH Bauunternehmung Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 234% points. The greatest weakness of Glass GmbH Bauunternehmung Konzern is the variable Operating Result Tc, reducing the Economic Capital Ratio by 2.372.484% points.

The company's Economic Capital Ratio, given in the ranking table, is 234%, being 136% points above the market average of 98%.
