

The relative strengths and weaknesses of Bremer Hamburg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bremer Hamburg GmbH compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 155% points. The greatest weakness of Bremer Hamburg GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 383% points.

The company's Economic Capital Ratio, given in the ranking table, is 155%, being 1,3% points below the market average of 156%.
