The greatest strength of Bien Zenker GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Bien Zenker GmbH is the variable Bs Eqliab Liab Remainder, reducing the Economic Capital Ratio by 3.524% points.

The company's Economic Capital Ratio, given in the ranking table, is 88%, being 68% points below the market average of 156%.
