The greatest strength of Hanova Services GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 49% points. The greatest weakness of Hanova Services GmbH is the variable Bs Eqliab Liab Remainder, reducing the Economic Capital Ratio by 1.076% points.

The company's Economic Capital Ratio, given in the ranking table, is 49%, being 107% points below the market average of 156%.
