The greatest strength of Degewo Technische Dienste GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 116% points. The greatest weakness of Degewo Technische Dienste GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.304% points.

The company's Economic Capital Ratio, given in the ranking table, is 116%, being 41% points below the market average of 156%.
