



The relative strengths and weaknesses of Wohnbauten GmbH Schwedt Oder are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbauten GmbH Schwedt Oder compared to the market average is the variable Bs Eqliab Liab Remainder, increasing the Economic Capital Ratio by 154% points. The greatest weakness of Wohnbauten GmbH Schwedt Oder is the variable Operating Result Tc, reducing the Economic Capital Ratio by 467% points.

The company's Economic Capital Ratio, given in the ranking table, is 154%, being 2,7% points below the market average of 156%.
