The greatest strength of Florack Bauunternehmung GmbH compared to the market average is the variable Bs Ass Currass Inventory Remainder, increasing the Economic Capital Ratio by 69% points. The greatest weakness of Florack Bauunternehmung GmbH is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 211% points.

The company's Economic Capital Ratio, given in the ranking table, is 69%, being 28% points below the market average of 97%.
