

The greatest strength of Ruben Schäfer Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 108% points. The greatest weakness of Ruben Schäfer Bauunternehmung GmbH is the variable Gross Revenue For The Period Tc, reducing the Economic Capital Ratio by 228% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 14% points above the market average of 97%.
