



The relative strengths and weaknesses of Reuter Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Reuter Bauunternehmen GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Remainder, increasing the Economic Capital Ratio by 103% points. The greatest weakness of Reuter Bauunternehmen GmbH is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 304% points.

The company's Economic Capital Ratio, given in the ranking table, is 142%, being 45% points above the market average of 97%.
