

The relative strengths and weaknesses of Ronak Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Ronak Bau GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 86% points. The greatest weakness of Ronak Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 514% points.

The company's Economic Capital Ratio, given in the ranking table, is 86%, being 11% points below the market average of 97%.
