The greatest strength of Hentschke Bau GmbH compared to the market average is the variable Bs Ass Currass Inventory Inprogress Remainder, increasing the Economic Capital Ratio by 110% points. The greatest weakness of Hentschke Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 399% points.

The company's Economic Capital Ratio, given in the ranking table, is 110%, being 13% points above the market average of 97%.
