



The relative strengths and weaknesses of Schneider Systembau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schneider Systembau GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 58% points. The greatest weakness of Schneider Systembau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 516% points.

The company's Economic Capital Ratio, given in the ranking table, is 58%, being 39% points below the market average of 97%.
