



The relative strengths and weaknesses of Laumer Bautechnik GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Laumer Bautechnik GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 211% points. The greatest weakness of Laumer Bautechnik GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 688% points.

The company's Economic Capital Ratio, given in the ranking table, is 211%, being 114% points above the market average of 97%.
