



The relative strengths and weaknesses of Gebr Nicklaus GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Gebr Nicklaus GmbH compared to the market average is the variable Bs Ass Currass Remainder, increasing the Economic Capital Ratio by 72% points. The greatest weakness of Gebr Nicklaus GmbH is the variable Bs Eqliab Liab Remainder, reducing the Economic Capital Ratio by 153% points.

The company's Economic Capital Ratio, given in the ranking table, is 76%, being 21% points below the market average of 97%.
