The greatest strength of Otto Mühlherr Baugesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 75% points. The greatest weakness of Otto Mühlherr Baugesellschaft mbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 3.796% points.

The company's Economic Capital Ratio, given in the ranking table, is 75%, being 287% points below the market average of 361%.
